

New Appointments to the Accounting and Corporate Regulatory Authority (ACRA) Board

Mr Ramlee Bin Buang was appointed as a Member of the Public Service Commission (PSC) by the President with effect from 1 August 2022, for a five-year term in the first instance.

Mr Ramlee has more than 30 years of experience with multinational corporations in business development and corporate roles ranging from General Manager to Chief Financial Officer, Finance and Business Development Director. He was the Executive Vice President, Chief Finance Officer, and Director of Cerebos Pacific, before he set up Uyko Advisory which he founded in 2014 to provide corporate advice, mentorship, and coaching.

He is active in the community, and he is a board member of the National Healthcare Group and the Singapore University of Technology and Design, for both of which he chairs the Audit and Risk Committees. He is on the board of Halogen Foundation (Singapore) for which he also serves as the Investment Committee Chairman, and he also chairs the board of 1FSS Pte Ltd, an MOH Holdings Finance Shared Service Centre. Outside the public sector, Mr Ramlee is a board member of Far East Orchard Limited.

Mr Ramlee is a member of the Chartered Association of Certified Accountants (United Kingdom), CPA (Australia) and was a Council Member of the Singapore Accountancy Commission.

He was conferred the Public Service Medal (PBM) in 2018.

Mr Tan Puay Boon was appointed as Chairman of the Competition Appeal Board under the Ministry of Trade and Industry with effect from 1 September 2021.

Mr Tan has over 30 years of experience in the Singapore Legal Service (both on and off the Bench). He joined the Attorney-General's Chambers as a State Counsel in 1987 and was posted to the Supreme Court as a Senior Assistant Registrar from 1991 to 1995. He was a District Judge of the then Subordinate Courts (now the State Courts) from 1995 to 2006, where he dealt with a range of cases covering civil, criminal, and family law matters.

In January 2007, Mr Tan was appointed Director of the Legal Aid Bureau, Ministry of Law. He was, concurrently, the Chief Information Officer of the Ministry from June 2013 to April 2015. He was awarded the Public Administration Medal (Gold) in 2014.

Mr Tan returned to the State Courts in April 2015 and was the Principal District Judge of the Civil Justice Division before his appointment as a Judicial Commissioner (JC) of the Supreme Court on 12 March 2018. During his term as a JC, he handled a variety of family cases in the High Court. Mr Tan completed his three-year term on the Supreme Court Bench on 11 March 2021.

Mr Tan was appointed Senior Counsel (*honoris causa*) in 2022 in recognition of his outstanding contribution to the development of the law.
