Mr Desmond Chin, 55, joined the Singapore Prison Services (SPS) in 1990, after graduating with a Bachelor of Social Science (Hons) degree in Social Work from the National University of Singapore.

Desmond was appointed Commissioner of Prisons on 1 October 2016. Prior to that, he held several key positions in Ministry of Home Affairs, among them was Head Joint Operations and Emergency Planning, Deputy Commissioner of Prisons and Chief-of-Staff. He also served as the Chief Executive Officer of Yellow Ribbon Singapore (formerly known as the Singapore Corporation of Rehabilitative Enterprises) from 2005 to 2010. He was awarded the Public Administration Medal (Gold) in 2020.

Desmond led the SPS to break new ground. New regimes were implemented, leading to improvements in recidivism rates of young offenders and drug inmates over time. SPS is widely acknowledged to be a leading employer in Singapore, with strong branding and recognition for its Captains of Lives initiative. It had also strengthened its relationships with a diverse range of partners, including community organisations, religious groups, halfway houses, volunteers, and befrienders. This helped garner their support in aiding the reintegration of ex-offenders into the community.
