Mrs Chng Sok Hui (林淑慧)

Mrs Chng Sok Hui is the Chief Financial Officer of DBS Group, and a member of the DBS Executive Committee. Prior to this appointment in October 2008, she was the Managing Director and Head of Risk Management at DBS Group and held the position for six years.

She serves as Supervisor of the board of DBS Bank (China) Limited, and on the board of the Bank of the Philippine Islands. She represents DBS in several industry and professional forums and had previously served on the Executive Committee of the Global IFRI Chief Risk Officer Forum, as well as the Tax Advisory Committee under the Ministry of Finance.

Mrs Chng is a Chartered Financial Analyst (CFA), a Certified Financial Risk Manager (FRM) as well as a Chartered Accountant (CA, Singapore). She received AsiaRisk's Risk Manager of the Year Award in 2002. He served on several boards including the Monetary Authority of Singapore, Singapore Press Holdings Ltd, ST Engineering Ltd, Hotung Investment Holdings Ltd and Prudential Assurance Co Singapore (Pte) Ltd, the Singapore Stock Exchange Ltd and Singapore General Hospital Pte Ltd.

Dr Pillai started his career teaching at the Faculty of Law, National University of Singapore between 1972 to 1986, obtaining his LLB (First) Hons from the University of Singapore, LLM and SJD from Harvard.
