

ANNEX E-4: MEASURES TO SUPPORT CHARITIES AND ENCOURAGE PHILANTHROPY

I. Extension of Tote Board's Enhanced Fund-Raising Programme (EFR)

Together with Tote Board, the Government will continue providing dollar-for-dollar matching for another three years (FY2022 to FY2024), capped at \$250,000 per year per charity for eligible local charitable causes. This applies to donations raised during fund-raising events, or on approved digital platforms such as Giving.sg.

After a charity utilises the annual \$250,000 dollar-for-dollar matching cap, Tote Board will continue to provide 40% matching for eligible fund-raising projects, capped at \$100,000 per fund-raising project. Each charity may submit a maximum of five applications a year.

II. Top-up to the Charities Capability Fund (CCF)

The CCF provides support to strengthen the governance and management capabilities of charities. The CCF has five different grants on training, consultancy, shared services, Info-Communications Technology (ICT), and collaboration (see [Table 1](#)).

The Government will provide a top-up of \$26 million to the CCF and will extend the scheme for another five years, from FY2022 to FY2026.

Table 1: Types of Grants under CCF

S/N	Grant Type	Brief Description
1.	Training Grant	For local training courses to help charities comply with regulatory requirements and build good governance standards.
2.	Consultancy Grant	For charities to engage external consultants for governance and management consultancy projects.
3.	Shared Services Grant	For charities that outsource their payroll, finance, accounting, human resource, and information technology functions to a third-party service provider.
4.	ICT Grant	For small and medium charities to harness ICT for their operations. Large charities will also be eligible for certain categories of ICT Grant, such as digital solutions.
5.	Collaboration Grant	For charities to collaborate on projects that enhance governance and management capabilities.

III. Extension of the One Team Singapore Fund (OTSF)

The OTSF is a dollar-for-dollar matching grant which matches cash donations to support Team Singapore athletes. Cash donations are only eligible for matching if they are donated to the Vision 2030 Fund or eligible National Sports Associations.

To support our High Performance Sport system, the Government will extend the OTSF for five years, from FY2022 to FY2026. MCCY will announce more details.

IV. Top-up to the Cultural Matching Fund (CMF)

The CMF aims to encourage broad-based cultural philanthropy through the provision of dollar-for-dollar matching for private cash donations to eligible arts and heritage charities.

To encourage continued giving to the arts and heritage sector, the Government will provide a \$150 million top-up to the CMF and extend the scheme for three years, from FY2022 to FY2024.
