## **ANNEX F-2: ASSURANCE PACKAGE FOR GST**

At Budget 2020, the Government announced a \$6 billion Assurance Package (AP) for GST to cushion the impact of the planned GST increase for all Singaporeans.

The Government will top-up \$640 million to enhance the AP. Under the enhanced AP, the majority of Singaporean households will receive offsets to cover at least five years' worth of additional GST expenses. Lower-income households will receive offsets covering about ten years' worth of additional GST expenses. The details are in the <u>Appendix</u>.

# (A) AP Cash Payouts

Every Singaporean aged 21 years and above will receive cash payouts amounting to between \$700 to \$1,600, depending on his/her income and property ownership (see <u>Table 1</u>). The payouts will be disbursed over five years, from 2022 to 2026. The first payout will be made in December 2022.

This will benefit about 2.8 million adult Singaporeans.

## (B) GST Voucher - Cash (Seniors' Bonus)

There will be additional cash payouts of \$600 to \$900 for less well-off Singaporean seniors through the special GSTV – Cash (Seniors' Bonus). Refer to <u>Table 2</u> for the payout criteria. The special GSTV – Cash (Seniors' Bonus) will be disbursed over three years, from 2023 to 2025.

This will benefit about 850,000 lower-income senior Singaporeans.

## (C) Additional GST Voucher – U-Save

All eligible HDB households will receive additional GST Voucher (GSTV) – U-Save rebates under the AP. These additional GSTV – U-Save rebates are on top of the regular GSTV – U-Save rebates under the GSTV scheme, and will be credited together with households' regular GSTV – U-Save in the relevant months (see <u>Table 3</u>). The additional GSTV – U-Save rebates for 2023 will be credited in January 2023.

The above will benefit about 950,000 Singaporean households.

#### (D) MediSave Top-ups

Singaporeans aged (i) 20 years and below, or (ii) 55 years and above, will receive a MediSave top-up of \$450 over 2023 to 2025 (see <u>Table 4</u>).

This will benefit about 2.0 million Singaporean children and seniors.

#### (E) Community Development Council (CDC) Vouchers Scheme

The Government will partner the CDCs to distribute two rounds of vouchers to all Singaporean households, in 2023 and 2024. Each round of vouchers will be worth \$200 (i.e. \$400 in total), and these vouchers can be used at participating heartland shops and hawker centres, as well as major supermarkets. The CDCs will provide more details on the vouchers subsequently.

## (F) Top-up to Citizens' Consultative Committee ComCare Fund

The Government will top up \$5 million to the Citizens' Consultative Committee (CCC) ComCare Fund over five years. Vulnerable households with urgent needs can approach their CCCs for assistance.

## (G) Grants to Self-Help Groups

The Government will also provide a total of \$12 million over four years to Self-Help Groups. These are the Chinese Development Assistance Council (CDAC), Eurasian Association (EA), Yayasan MENDAKI, and the Singapore Indian Development Association (SINDA).
