

**ANNEX E-1: INTERIM UPDATE ON FINANCIAL YEAR 2021**  
**(AS AT 5 JULY 2021)**

1. The Revised FY2021 fiscal position is summarised in Table 1.
2. Operating Revenue is projected to decrease by \$0.1 billion compared to the estimates presented in February 2021 (“Estimated FY2021”), due to revenue foregone for the waiver of rental charges to support individuals and businesses during periods of heightened Safe Management Measures.
3. Total Expenditure is expected to have a net decrease of \$0.5 billion compared to Estimated FY2021, as increases in operating expenditure for targeted support to affected individuals are offset by decreases in development expenditure mainly due to construction delays in view of COVID-19.
4. Special Transfers is expected to increase by \$1.0 billion compared to Estimated FY2021, due to measures to support businesses and individuals during periods of heightened Safe Management Measures, through the Jobs Support Scheme and rental relief.
5. Capitalisation of Nationally Significant Infrastructure under the Significant Infrastructure Government Loan Act (SINGA) is expected to free up an additional \$0.6 billion compared to Estimated FY2021.
6. Taken together, the revised overall fiscal deficit is \$11.0 billion. There is no net increase in overall fiscal deficit compared to Estimated FY2021, and no further draw on past reserves.
